ORDER

On August 12, 1997, CIMCO Communications, Inc., (CIMCO) filed an application, pursuant to the Michigan Telecommunications Act, MCL 484.2101 *et seq.*, for a license to provide basic local exchange service. On November 25, 1997, the Commission granted the application. On May 25, 2010, CIMCO informed the Commission of its intent to surrender the license. CIMCO states that it has no customers and has ceased operations in Michigan.

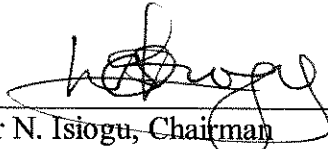
THEREFORE, IT IS ORDERED that:

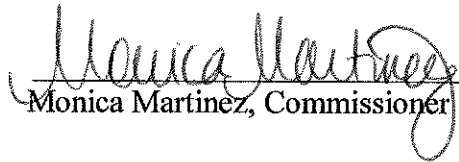
- A. The license of CIMCO Communications, Inc., to provide basic local exchange service is rescinded.
- B. CIMCO Communications, Inc., shall surrender to the North American Numbering Plan Administrator any numbers that have been assigned to it.

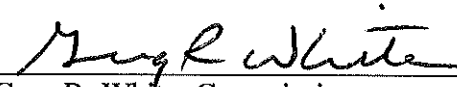
The Commission reserves jurisdiction and may issue further orders as necessary.
