ORDER

On June 16, 1997, Verizon Select Services, Inc., f/k/a GTE Communications Corporation, filed an application, pursuant to the Michigan Telecommunications Act, MCL 484.2101 *et seq.*, for a license to provide basic local exchange service in the exchanges served by GTE North Incorporated and Ameritech Michigan. On December 12, 1997, the Commission granted the application. On January 20, 2015, Verizon Select Services, Inc., f/k/a GTE Communications Corporation, informed the Commission of its intent to surrender the license. Verizon Select Services, Inc., f/k/a GTE Communications Corporation, states that it does not offer basic local exchange service in the state of Michigan and does not plan to do so in the future.

THEREFORE, IT IS ORDERED that:

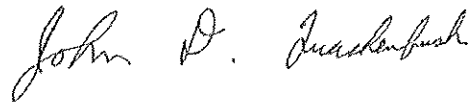
A. The license of Verizon Select Services, Inc., f/k/a GTE Communications Corporation, to provide basic local exchange service is rescinded.

B. Verizon Select Services, Inc., f/k/a GTE Communications Corporation, shall surrender to the North American Numbering Plan Administrator any numbers that have been assigned to it.

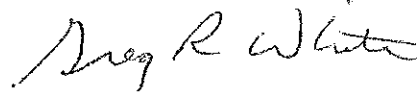
The Commission reserves jurisdiction and may issue further orders as necessary.

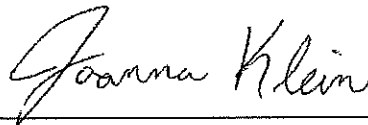

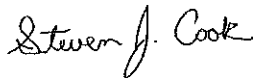
