Consumers Energy Company ("Consumers Energy") makes this corrected annual informational filing of customers enrolled in its load reduction program for the year 2005, as required by the Commission's Order Approving Application dated February 9, 2000. The Order provides: "Consumers Energy Company shall file each year on the anniversary of this order information on the number of customers enrolled in its load reduction program and the corresponding load reduction accomplished."

Consumers Energy had 14 customers enrolled in its load reduction program in the year 2005, with potential kW capacity of 81.9 MW. Consumers Energy enacted **351.8** MW in 2005, resulting in a total of 2, 377.568 MWh.
