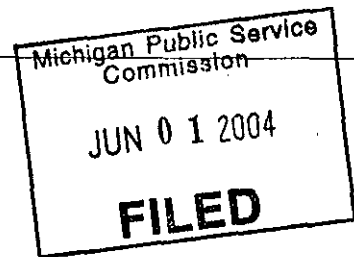

On January 22, 1988 Consumers Energy Company filed four copies of the Tariff Book of Standard Forms. The Tariff Book of Standard Forms was stamped approved as filed on February 2, 1988. Subsequent revisions to the Tariff Book of Standard Forms were filed since that date.

Form 614 - Contract for Electric Service - For Operation of Private Street or Roadway Lighting in Mobile Home Park dated 4-2004

Form 615 - Agreement for Unmetered Lighting Service dated 4-2004

Form 916 - Contract for Electric Service - Special Minimum Charges dated 4-2004

Form 917 - Contract for Electric Service - Resale to Tenants dated 4-2004

The above forms were revised incorporating the Company's new address at "One Energy Plaza - Jackson, MI 49201-2276" and incorporating "Page X of X" on the bottom far right hand corner of each page of the contract.

Form 2801 - Electric Service Request - Customer Copy dated 10-2003 - Revised the "Customer Responsibilities" Section at the bottom of the form to better clarify the customer's requirements that must be met before the Company installs the customer's new service.

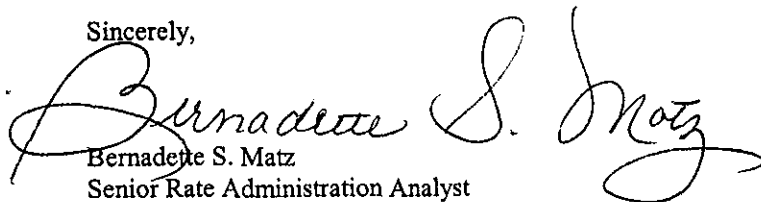
Form 3812 - Customer Bill dated 5-2004 - Revised incorporating "(Form Page X of X)" on the bottom far left hand corner of each page of the bill.

Form 3815 - Customer Bill dated 5-2004 - Revised incorporating "(Form Page X of X)" on the bottom far left hand corner of each page of the bill and deleting references to Rate F-1 and ROA-SB.
