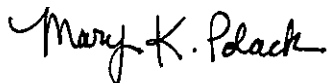

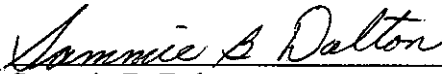

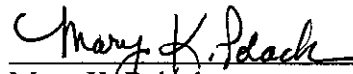

The Michigan Public Service Commission (Commission) will hold a public hearing to consider Consumers Energy Company's (Consumers) July 18, 2000 request for approval of a

price change under its gas purchase agreement with Delta Energy Corporation. Consumers states that it has reached agreement with Delta Energy for a price change from \$2.40 per MMBtu to \$3.25 per MMBtu, effective January 1, 2001.
