ORDER

On September 1, 2000, WilTel Local Network, LLC, f/k/a Williams Local Network, Inc. (WilTel), filed an application, under the Michigan Telecommunications Act, MCL 484.2101 *et seq.*, for a license to provide basic local exchange service. On May 15, 2001, the Commission granted the application. On September 30, 2008, WilTel indicated its intent to surrender the license. WilTel states that it has no facilities or customers in Michigan, and offers no services in Michigan.

THEREFORE, IT IS ORDERED that:

A. The license of WilTel Local Network, LLC, to provide basic local exchange service is rescinded.

B. WilTel Local Network, LLC, shall surrender to the North American Numbering Plan Administrator any numbers that have been assigned to it.

The Commission reserves jurisdiction and may issue further orders as necessary.

Any party desiring to appeal this order must do so in the appropriate court within 30 days after issuance and notice of this order, under MCL 462.26.
