Dear Ms. Kunkle:

360networks (USA) inc. ("360networks") and AboveNet Communications, Inc. ("AboveNet" and together, the "Companies"), by their undersigned counsel, hereby voluntarily surrenders their Authorizations. 360networks is authorized to provide (1) basic local exchange services pursuant a license granted in Docket No. U-12685 and (2) interexchange services pursuant to its ITSP Registration and AboveNet is authorized to provide basic local exchange services pursuant to a license granted in Docket No. U-12674¹ (collectively, the "Authorizations"). The Companies, therefore, requests that the Commission cancel the Companies' Authorizations and withdraw all tariff(s) on file with the Commission, effective immediately or as soon as the Commission can take such action. Further, in the event that either company has a current bond or letter of credit on file with the Commission, the Companies requests that the Commission authorize the cancellation of the bond or letter of credit and return it to them.

The Companies do not provide telecommunications services in Michigan and have no plans to do so in the future. The Companies, therefore, no longer require their Authorizations. Because the Companies do not serve any customers or have any active telecommunications operations in Michigan, the Companies respectfully submit that the surrender of their Authorizations and withdrawal of their tariff(s) is reasonable and necessary and will not be disruptive to the present or future public interest, convenience and necessity.

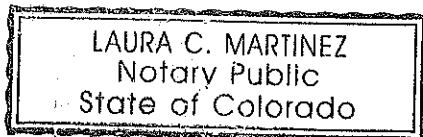

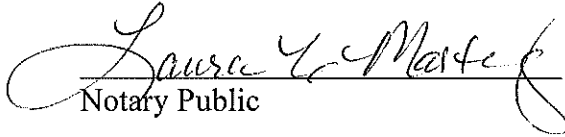
