ORDER

On October 23, 2000, AboveNet Communications, Inc., f/k/a Metromedia Fiber Network Services, Inc., (Metromedia) filed an application, pursuant to the Michigan Telecommunications Act, MCL 484.2101 et seq., for a license to provide basic local exchange service in all zones and exchanges then served by Verizon North Inc., Contel of the South, Inc., d/b/a Verizon North Systems, and Ameritech Michigan. On January 23, 2001, the Commission granted the application.

On November 19, 2012, Metromedia informed the Commission of its intent to surrender the license. Metromedia states that it has no customers and has ceased operations in Michigan.

THEREFORE, IT IS ORDERED that:

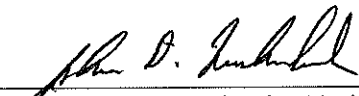
A. The license of AboveNet Communications, Inc., f/k/a Metromedia Fiber Network Services, Inc., to provide basic local exchange service is rescinded.

B. AboveNet Communications, Inc., f/k/a Metromedia Fiber Network Services, Inc., shall surrender to the North American Numbering Plan Administrator any numbers that have been assigned to it.

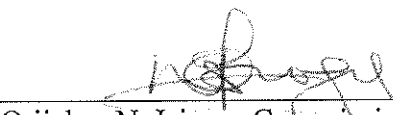
The Commission reserves jurisdiction and may issue further orders as necessary.

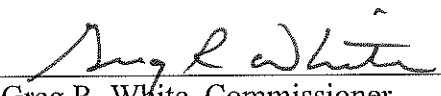

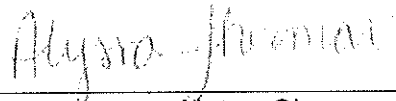
