ORDER

The following parties have filed joint applications for approval of interconnection agreements
or amendments to an interconnection agreement:

Case No. U-12952	AT&T Michigan and TDS Metrocom, LLC Application filed October 8, 2020, for approval of a twenty-sixth amendment to the interconnection agreement (adds terms and conditions to implement the Petition of US Telecom for Forbearance Pursuant to 47 U.S.C. 160(c) to Accelerate Investment in Broadband and Next-Generation Networks, WC Docket No. 18-141, FCC 19-66 and FCC 19-72, filed May 4, 2018; and extends the term of the twenty-fourth amendment pertaining to the approved Performance Measures and Remedies Plan to December 31, 2022).
Case No. U-20913	Blanchard Telephone Co. and Winn Telephone Company, d/b/a Winn Telecom Application filed October 8, 2020, and amended application filed October 13, 2020, for approval of an interconnection and mutual traffic exchange agreement.
Case No. U-20914	AT&T Michigan and Climax Telephone Company Application filed October 7, 2020, for approval of a Traffic Termination Agreement.

47 USC 252(e)(2) and (3) provides in part:

- (2) The State commission may only reject
 - (A) an agreement (or any portion thereof) adopted by negotiation under subsection (a) of this section if it finds that--
 - (i) the agreement (or portion thereof) discriminates against a telecommunications carrier not a party to the agreement; or
 - (ii) the implementation of such agreement or portion is not consistent with the public interest, convenience, and necessity;
- (3) Notwithstanding paragraph (2), but subject to section 253 of this title, nothing in this section shall prohibit a State commission from establishing or enforcing other requirements of State law in its review of an agreement, including requiring compliance with intrastate telecommunications service quality standards or requirements.

After reviewing the applications, the Commission finds that they should be approved. The Commission finds that the agreements and amendments are consistent with federal and state law and are in the public interest. Under 47 USC 252(i) and MCL 484.2359(2), the services provided under the agreements shall be made available to other telecommunications carriers upon the same terms and conditions.

THEREFORE, IT IS ORDERED that:

- A. The interconnection agreements and amendments listed above are approved.
- B. Approval of the interconnection agreements and amendments does not alter the duty of the parties to comply with relevant federal and state law and past and future Commission orders and rules.

The Commission reserves jurisdiction and may issue further orders as necessary.

Any party aggrieved by this order may file an action in the appropriate federal District Court under 47 USC 252(e)(6). To comply with the requirement to notify the Commission of an appeal, appellants shall send required notices to both the Commission's Executive Secretary and to the Commission's Legal Counsel. 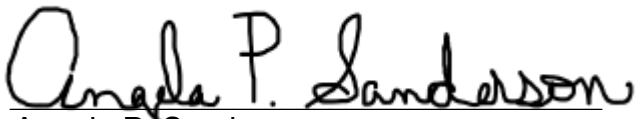
