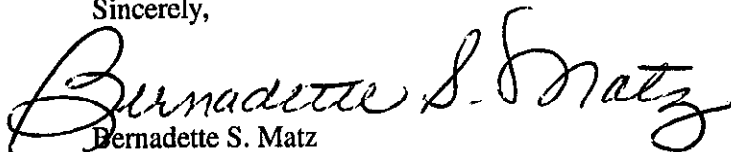
REFILING RATES - MPSC NO. 12 - ELECTRIC
