AMENDED NOTICE OF IMPLEMENTATION OF ETHICAL SCREENING WALL

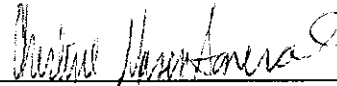
4. The files concerning the pending case have been marked with special coding to designate them so that Mr. Oginsky does not inadvertently view the contents of the file;

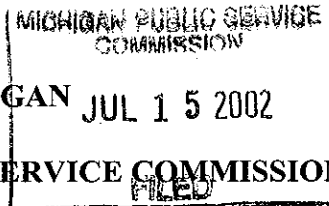

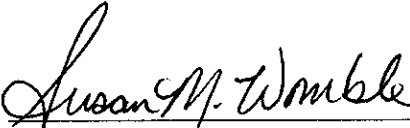

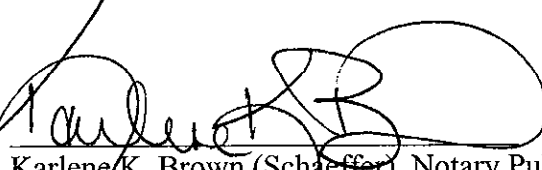
