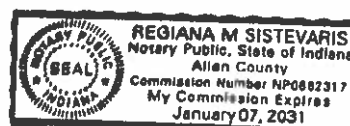

The Michigan Public Service Commission (Commission) will hold a pre-hearing to consider Indiana Michigan Power Company's (I&M) June 26, 2026 application requesting the Commission to: 1) approve I&M to commence a Renewable Energy Cost Reconciliation proceeding for the 12-month period ended December 31, 2025; 2) approve zero (0) Renewable Energy Credits as I&M's 2024 Renewable Energy Credit compliance obligation set forth in 2008 PA 295, as amended; 3) determine that I&M is in compliance with the renewable energy standard requirements set forth in 2008 PA 295, as amended, for the 2025 compliance period; 4) approve as reasonable and prudent I&M's reconciliation of the Renewable Energy Plan regulatory liability balance and total actual cost of compliance through December 31, 2025, resulting in a regulatory liability, including carrying charges, of \$21,617,135; and 5) grant I&M such other and additional relief as the Commission may deem reasonable and appropriate.

All documents filed in this case shall be submitted electronically through the Commission's E-Dockets website at: <https://mi-psc.my.site.com/s/>. Any person wishing to intervene and become a party to the case shall electronically file a petition to intervene with this Commission by August 4, 2026. (Interested persons may elect to file using the traditional paper format.) The

The prehearing is scheduled to be held remotely by video conference or teleconference. Persons filing a petition to intervene will be advised of the process for participating in the hearing.

Any person wishing to appear at the hearing to make a statement of position without becoming a party to the case may participate by filing an appearance. To file an appearance, the individual must attend the hearing and advise the presiding administrative law judge of their wish to make a statement of position. Mich Admin Code, R 792.10413 (Rule 413).

Any person wishing to file a public comment may do so by filing a written statement in this docket. The written statement may be mailed or emailed and should reference Case No. **U-22028**.
