ORDER

On July 15, 2026, Eric Totz (Complainant) filed a formal complaint with the Commission against DTE Energy Company (DTE) alleging the company shut off gas service without proper notice. On August 6, 2026, the Complainant filed notice in this docket requesting withdrawal of his complaint and that the proceeding be dismissed with prejudice.

The Commission finds that the complaint filed by the Complainant against DTE should be dismissed with prejudice because the Complainant has requested this in writing.

THEREFORE, IT IS ORDERED that the complaint filed by Eric Totz against DTE Energy Company is dismissed with prejudice.

The Commission reserves jurisdiction and may issue further orders as necessary.

Any party desiring to appeal this order must do so in the appropriate court within 30 days after issuance and notice of this order, pursuant to MCL 462.26. To comply with the Michigan Rules of Court's requirement to notify the Commission of an appeal, appellants shall send required notices to both the Commission's Executive Secretary and to the Commission's Legal Counsel. 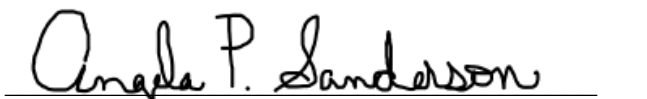
